

Beim Goods Accessibility TTS Tool Terms of Service

Effective Date: May 31, 2026

Last Updated: June 10, 2026

Scope: These Terms apply exclusively to the Beim Goods Accessibility TTS Tool (Phase 1). Separate terms govern future products and services.

1. Agreement to Terms

By installing or using the Beim Goods Accessibility TTS Tool browser extension ("the Extension"), you agree to be bound by these Terms of Service ("Terms"). If you do not agree, do not install or use the Extension.

The Extension is operated by Beim Goods, a registered DBA in the State of Texas.

2. Description of Service

The Beim Goods Accessibility TTS Tool is a browser extension that provides text-to-speech accessibility functionality on supported streaming websites (e.g. Amazon Live, eBay Live, Poshmark, YouTube, Kick, Twitch, and StreamYard). It reads system-generated tip menu messages aloud to assist streamers and content creators during live sessions.

The Extension includes:

- A 30-day free trial upon installation
- A \$1.00/month subscription plan after the trial period ends
- Automatic monthly subscription renewal until cancelled
- Easy cancellation link via browser display bar or right click the extension icon

3. Free Trial

New users receive a 30-day free trial beginning on the date of installation. No payment information is required to start the trial. At the end of the trial period, TTS functionality will be paused unless a subscription is activated.

4. Subscription and Billing

After the free trial, continued use of TTS features requires a paid subscription at \$1.00 USD per month.

- Subscriptions are billed monthly and auto-renew automatically.
- You may cancel your subscription at any time. Cancellation takes effect immediately.

- Billing is processed by Stripe. Beim Goods does not store your payment card information.
- All charges will appear on your statement as "Beim Goods".
- **Important: like most software products, uninstalling the Extension does not cancel your subscription. To stop being charged, you must cancel your subscription through the Stripe Customer Portal.**
- Three ways to manage your subscription, 1) an in-browser text bar in the lower left corner shows "Manage subscription", 2) clicking on the three dots next to the Extension icon displays a drop down menu, select "Manage subscription", 3) visit: <<https://billing.stripe.com/p/login/eVq9AT8Uv8bi2SRcsgdwc00>>

5. Refund Policy

You may cancel your subscription at any time. To cancel, visit the Stripe Customer Portal at <https://billing.stripe.com/p/login/eVq9AT8Uv8bi2SRcsgdwc00>.

Because Beim Goods offers a 30-day free trial before any charge is applied, all subscription payments are non-refundable except in cases of billing error. If you believe you have been charged in error, contact us within 30 days of the charge.

Stripe charges a processing fee of 2.9% + \$0.30 per transaction. This fee is not collected by Beim Goods and is non-refundable by Stripe. In the event a refund is approved, the Stripe processing fee will be deducted from the refund amount. Refunds are processed within 5–10 business days to the original payment method.

6. Acceptable Use

You agree not to:

- Reverse engineer, decompile, or modify the Extension
- Use the Extension for any unlawful purpose
- Attempt to bypass, circumvent, or disable any license verification or payment mechanisms
- Share or resell access to the Extension

7. Intellectual Property

The Beim Goods Accessibility TTS Tool, including its code, design, and branding, is the property of Beim Goods. All rights reserved. You are granted a limited, non-exclusive, non-transferable license to use the Extension for personal or business use in accordance with these Terms.

8. Privacy

9. Disclaimers

The Extension is provided "as is" without warranties of any kind, express or implied. Beim Goods does not warrant that the Extension will be uninterrupted, error-free, or compatible with all websites or browser versions.

10. Limitation of Liability

To the fullest extent permitted by law, Beim Goods shall not be liable for any indirect, incidental, special, or consequential damages arising from your use of the Extension. Our total liability shall not exceed the amount you paid us in the 30 days preceding the claim.

11. Modifications to Terms

We may update these Terms at any time. Continued use of the Extension after changes are posted constitutes acceptance of the revised Terms. We will update the "Last Updated" date at the top of this document.

We reserve the right to change subscription pricing with 30 days advance notice. Existing subscribers will be notified.

12. Future Products

These Terms apply only to the Beim Goods Accessibility TTS Tool (Phase 1). Future Beim Goods products, including hardware devices and text-to-action features, will be governed by separate terms of service published at the time of their release.

13. Governing Law

These Terms are governed by the laws of the State of Texas, without regard to conflict of law provisions. Any disputes shall be resolved in the courts of Texas.
